THEY ARE EXPENSIVE AND ARE NOT COVERED BY TRADITIONAL GOVERNMENT ASSISTANCE PROGRAMS. WESTSIDE BABY FILLED THIS GAP IN 2022 BY PROVIDING MORE THAN 2,617,485 DIAPERS TO FAMILIES IN NEED. THIS PROGRAM SUCCEEDS IN PART DUE TO DIAPER DONATIONS BY INDIVIDUALS AND COMMUNITY DIAPER DRIVES, AS WELL AS SUPPORT FROM THE NATIONAL DIAPER BANK NETWORK. WESTSIDE BABY ALSO PURCHASES DIAPERS TO SUPPLEMENT DONATIONS. STAFF CONDUCTS OUTREACH AND COORDINATES MANY DIAPER DRIVES THROUGHOUT THE YEAR TO COLLECT FOR THIS PROGRAM. IN ADDITION, SYSTEMS AND OVERSIGHT ARE REQUIRED FOR ORDERING, PROCESSING AND DISTRIBUTION OF THIS BASIC RESOURCE.

ENSURING THERE ARE ENOUGH DONATIONS OF ITEMS COMING IN, VOLUNTEERS TO PROCESS THEM, SPACE TO STORE THEM AND SYSTEMS TO ADMINISTER THE PROGRAM IS CENTRAL TO OUR IMPACT.
