WESTSIDE BABY ALSO PURCHASES NEW ITEMS, INCLUDING DIAPERS AND HYGIENE SUPPLIES. THE ORGANIZATION DISTRIBUTES ITEMS DIRECTLY TO A BROAD RANGE OF 100+ SOCIAL SERVICE PARTNER AGENCIES, WHO WORK CLOSELY WITH THE FAMILIES AND CHILDREN THEY SERVE. THESE PROFESSIONALS GET THE ITEMS THE CHILDREN NEED, AND WESTSIDE BABY FOCUSES ON COLLECTING THE BASIC ESSENTIALS.
